All players must be of legal drinking age in the State of Ohio and must have played a minimum of nine (9) nights in one session, or twelve (12) nights in two sessions, to be eligible to compete at the state tournament. Players can only play in ONE singles event at the state tournament. All players must be at least 21 years of age. Players may compete in the singles tournament even if they did **NOT** compete in the State Team Championships this year. **ALL PLAYERS MUST WEAR A MASK WHILE IN THE ARENA. ANY PLAYER THAT DOES NOT WEAR A MASK WILL BE ASKED TO LEAVE AND FORFEIT ALL PRIZES AND MONEY.**

**Player Note:** This certificate must be turned in at the OCMA registration desk. **DO NOT LOSE THIS CERTIFICATE AS NO PLAYER CAN COMPETE WITHOUT A COMPLETELY FILLED OUT CERTIFICATE THAT IS SIGNED BY THE CHARTER HOLDER.** Random ID and registration form checks will be conducted at the tournament. If a player does not have a registration form or individual ID, they may be disqualified.

A copy is to be retained by the Charter Holder & Player. **\*Earlier deadline for some charters may be required if the 25% and 50% of entry deadline dates are not followed.**

**Player must be present at registration day to sign the form at check-in.**

**DRESS CODE, ETC.:** No gambling, No sleeveless shirts or tops, No halter tops, No tube tops, No midriffs, No cut-offs, No swim suits, No tank tops, No vulgar language at any time, No open toe shoes or flip-flops (players will be disqualified). All shorts must be clean, neat, presentable, hemmed and of proper length to be allowed. Tournament officials will have the right to ask any player or spectator not properly attired to leave the playing area.
